The People of the United States had our lawful Republican form of governance deceptively taken from us long ago before any of us were born when the *Act to Provide a Government for the District of Columbia* was enacted by The FORTY-FIRST CONGRESS Session III in CHAP. LXII on February 21, 1871. Most Americans believe and assume that their Federal Government is a legitimate Constitutional republic form of governance when in reality it is a foreign owned corporation for profit siphoning off wealth and liberty from the People, while acting as a government.

Some Americans have discovered the truth and now understand why the American People have been abused along with other People around the world. Over many years, all of America's media, public schools, political parties, courts, financial systems, business, and all aspects of life were slowly and secretly taken over by bankers behind the UNITED STATES municipal corporation. The American people have been abused, imprisoned, and had our wealth taken away just as many of the other People around the world.

Americans are discovering how this unlawful corporate Federal Government has caused harm, financially and physically to other Peoples and Nations of the world. We wish our predecessors would have stopped them long ago and returned the United States of America back

We show tolerance and respect to corporate law enforcement officers even when these officers, through lack of knowledge, may violate or infringe upon our un-a-lienable guaranteed liberties. We want the American People to know that many loyal Americans as well as friends of this nation are working to expose the unlawful actions of this corporate Federal Government and all the associated corporations and people involved. Our goal is to stabilize America and its economy, with the intent of freeing the American People and People of the world from unscrupulous banking interests. The rule of law should be applied equally to all mankind, requiring justice for the innocent as well as for those proven guilty of atrocities that have been committed in the name of the American People. Not all Americans are aware of the TRUTH about their Nation and the unlawful corporate government that is controlling their lives. Many Americans refuse to believe the truth or they dare not speak about the truth for fear of being punished or put into prison for things that do not warrant such treatment.

<u>The Republic for the United States of America has been reinhabited</u>

On July 4, 1776 our American Founding Fathers signed a Declaration of Independence that changed the world forever. It was the first time in history that a group of common people had declared their God given right to be free from the oppression of a tyrant king. It was a new idea. The revolutionary war was fought and won under the direction of General George Washington who became the first President of the United States of America. A Congress was convened and a constitution ratified with the Bill of Rights *circa* 1791. This constitution created and guaranteed a Constitutional Republic to and for the American People. The actions of our founding Fathers set us on a path that created one of the greatest nations on earth.

Foreign banking interests influenced many in our nation and in our government to control our monetary system. During the American Civil War time frame Congress unlawfully created a new form of government and legal system to replace our constitutional Republic when the *Act to Provide a Government for the District of Columbia* was enacted by The FORTY-FIRST CONGRESS Session III in CHAP. LXII on February 21, 1871. The American Constitutional Republic was abandoned.

A few brave souls kept the fire of liberty smoldering slowly throughout the years. After years of research by many Americans, a solution to the unlawful municipal corporate government in Washington, D.C. was found. These Americans realized that Congress had never repealed the original Constitutional Republic. During the 1870's, they realized the Constitutional Republic could

not be lawfully destroyed, so they set it aside and moved forward with a new Corporate Democratic system of government. Only *We the People* had the lawful right and authority to change our system of government but the *de jure* Congress never asked us to decide. They unlawfully usurped the God given unalienable rights of the American People without our consent. This is in direct violation of our law and makes any actions taken since 1871 by the UNITED STATES municipal corporation null and void. They used a *de facto* legal system and an unlawful practice of implied consent without full disclosure to create an unlawful government to force their rule over the American People.

So, in 2010 We the People, through grand juries, gave public notice by warrant to the fifty corporate STATE governors which ordered restoration back to lawful de jure government. Once they refused, the People took lawful steps to re-inhabit the positions of the original Constitutional Republic. On September 23, 2010, elected statesmen and delegates from the free States in union gathered to establish an interim government as the 1st Congressional Assembly of the Republic of the United States of America. This gathering effectively established the first functional de jure government since the 1870s when the government was incorporated. Until 2010, the de jure Congress never had a quorum of constitutional office holders to lawfully re-convene. The Republic for the United States has lawfully fulfilled that requirement. We notified the corporation of our plans to re-inhabit the original Republic, and have lawfully done so. In short, the People have taken the necessary steps to lawfully re-inhabit our Republican form of governance.

Change is here; that change is the Republic for the United States of America and is being accomplished in peace and honor. Since November of 2010, the Republic for the United States of America has been the only lawful *de jure* government in America, however in a provisional capacity until the majority of Americans find out the truth. The Republic for the United States of America has the lawful right to operate as a parallel provisional government in America while the UNITED STATES municipal corporation collapses. Imminent collapse is the result of their immorality and failed economic/financial policies. The UNITED STATES municipal corporation has clearly sown the seeds of its' own destruction and will fall.

Many of us have been working for over two years and have risked our lives and fortunes to re-inhabit the Republic under the Almighty Creator's direction. This speaks volumes about the quality, character and dedication of the People who have struggled, many working full time without any compensation.

The UNITED STATES corporation and all its financial partners

are very large and powerful. With the help of God, the American People can prevail in lawfully preventing more atrocities from being committed. Our Nation must be restored back to a virtuous, righteous and honorable Nation in peace and harmony with the world. We humbly ask for your prayers and support as we go through this transition and may God have mercy on us all.

A Brief History Outline of the Republic for the United States of America

- 1. Civil War era 1860-1865
 - 1. War about debt
 - 2. The Lincoln green back helped saved Union
 - 3. People in influence to change form of governance.
 - 4. Lincoln was assassinated to keep him from restoring the Republic.
- 2. 1871 act to create government for Washington D.C.
 - 1. Act was done in fraud to create new form of governance for America.
 - 2. Act incorporated not only the District of Columbia but brought all the states in as territories.
 - 3. The governance was changed from a *de jure* republican form of government to a *de facto* corporate democracy.
 - 4. The new governance established the executive (President) in supreme authority and with little or no representation of *We the People* (Congress).
 - 5. A corporation does not have obligation to *We the People*.
 - 6. The *de jure* government positions were vacated and the Constitution of the United States of America was suspended.
- 3. Laws and governance today.
 - 1. Since 1871 the laws are not valid because they are only corporate rules and procedures.
 - 2. The corporation has the enforcement without the will of *We the People*.
 - 3. The Banks are all sub-corps of the Central Banks of Europe.
 - 4. The Banks do not follow rule of law and also do not follow the corporate rules and procedures.
 - 5. Common law and de jure laws are ignored and replaced with courts that are corporations for profit using commercial rules and procedures without concern for We the People and are only concerned with making a profit.
- 4. 2010 *de jure* government re-inhabited under the Constitution in law.
 - 1. The *de jure* government was re-inhabited.
 - 2. The Constitution of the United States of America

- was continued.
- 3. The *de jure* government continued the form of law (in a unanimous document called the *Declaration of Sovereign Intent* or DSI) as was used in the creation of the Constitution of the United States of America.
 - c.i. Common Law of God based on the Holy Bible
 - c.ii. Declaration of Independence
 - c.iii.Bill of Rights
 - c.iv. Constitution of the United States of America.
- 1. All things belonging to *We the People* and all the States were accepted in union and now referred to as the Republic for the United States of America.
- 2. All was done according to Law and the Laws up to 1871. The law cannot be ignored with the *de jure* government reinhabited.

What is needed by the Republic for the United States of America Today?

- 1. Understanding of the Lawful actions of the Republic for the United States of America in the re-inhabitation process.
- 2. Recognition of the lawful government of the United States of America re-inhabited known now as the Republic for the United States of America.
- 3. Recognition of the corporation that has unlawfully acted as the government of the United States.
- 4. All enforcement must be relinquished back to We the People.
- 5. The *de jure* laws (up to 1871) must be used by all courts along with common law and must be re-established and recognized as the rule of law.

- 3. Banking must be corrected.

- 5. Rebuild the United States economy back to the great nation that it once was.
